

MONTERAY SHORES MEMORIAL DAY PHOTOGRAPHY EXHIBITION PROSPECTUS

The Monterey Shores Memorial Day Photography Exhibition will showcase original photographs in either black and white or color. No digital art please. The exhibit will run from Friday, May 24, 2019 through Saturday, July 6, 2019 at the Clubhouse located at 925 S. Harbor View, Corolla, NC.

Guidelines and Requirements

1. We will only accept original photographs taken within the last three years by photographers 18 years or older at the time the photograph was taken and who are property owners or immediate family members of property owners of Monterey Shores in Corolla, NC.
2. Color or black and white photographs are eligible for submission with minimal photo correction. Digital art (photo-shopped pieces) are not acceptable. Photos **must** be 8"by 10" and express a general theme of "Outer Banks." Submissions will be uniformly mounted by exhibitor for display and **will not be able to be removed from mounting when returned to photographer.**
3. Exhibitor reserves the right to disqualify submission for any reason, including content, space availability, and lack of adherence to submission requirements. Content must be family-friendly.
4. Submissions will be accepted beginning March 15, 2019 through May 1, 2019. Photos may be dropped off at the Clubhouse in person during regular hours or mailed at photographer's expense to Monterey Shores, 925 S. Harbor View, Corolla, NC. Entries may be picked up in person beginning July 10, 2019 through September 9, 2019. Entries will not be returned by mail.
5. Receipt of the completed application form constitutes your agreement with all conditions established in this prospectus.

Awards

Entries will be judged for first, second, third and two honorable mention places with winners announced at the Artist's Reception (Sunday, May 26, from 1:00 to 2:30 is the tentative date). All awards are designated by the judge and are final. All photographers accepted into the show are encouraged to attend the reception.

A People's Choice Award will be determined by voting through the end of the show. All winning photographs will be displayed on the Monterey Shores HOA website from July 7, 2019 through September 7, 2019

2019 Judge-Robyn Scott

Ms. Scott was born in California, has a life-long connection to the Outer Banks, and currently resides in Raleigh. She received her B.A. from the University of California, Irvine with a major in Studio Arts, and her M.A. from the University of Southampton, Winchester School for the Arts, Winchester, England, with a concentration in Print Making. Ms. Scott is an award-winning artist who has exhibited her

drawings, photographs, and lino-cuts nationally. She has taught art classes in private school and conducted workshops in media techniques. She currently works with a variety of media.

Application & Fee

Submit your application and entry fee using the entry form. The non-refundable fee is \$5.00 per application and will be used to purchase uniform mounting materials. **PLEASE NOTE: ONCE MOUNTED, YOUR PRINT CAN NOT BE REMOVED FROM THE MOUNTING. YOUR PHOTO WILL BE RETURNED TO YOU MOUNTED ON ARTIST'S PAPER AND IN A WAY THAT IS ACCEPTABLE FOR DISPLAY AT THE CLUBHOUSE.** No framed photos accepted.

Delivery and Return of Work

Due to the remote location of the exhibition, the delivery time will be longer than usual. Photos may be submitted in person to the Clubhouse during regular business hours, or may be mailed to 925 S. Harbor View, Corolla, NC 27927 between March 15, 2019 and May 1, 2019. Artist assumes all risk to entries submitted by mail. Entries received after May 1, 2019 will not be displayed. **We can not return work by mail.** All photographs must be picked up in person prior to September 7, 2019. Any photos unclaimed after that date become the property of Monterey Shores HOA.

Liability

Receipt of the completed application form constitutes your agreement with all conditions established in the prospectus. Monterey Shores HOA does not provide insurance for any work submitted to the exhibition at any time. We will make every attempt to return your photograph, mounted for the exhibition, in good condition but offer no guarantees.
